### **CANCELLATIONS**

All cancellations must be advised in writing to plus@placemakers.co.nz.

Once the booking has been confirmed, a cancellation made within 30 days prior to departure date of 05 May 2025 will incur a fee of 100% of the total booking value in addition to the \$250 non-refundable cash deposit paid at your PlaceMakers store.

Cancellations made before the 30 days prior to departure will incur fees as outlined in the table below, in addition to the \$250 non-refundable cash deposit paid at your PlaceMakers store

## NAME CHANGES

If you are unable to travel, it may be possible for you to arrange a replacement traveller on the same flight itinerary. These changes will be treated as an amendment and the above conditions apply. Name changes within 48 hours prior to departure are not possible, and cancellation conditions are applicable.
